## Manor of Wootton and Boarshill in the County of Berkshire (15<sup>th</sup> April 1591)

View of Frankpledge and Court Baron

Held there for Richard Hyde, gentleman, by his steward there Thomas Rede, on the fifteenth of April in the thirty third year of the reign of our Lady Elizabeth, by the grace of God, Queen of England, France and Ireland, Defender of the Faith etc.

Apologies for absence on this day none

Presentments they state on their oath and present that (English) the butts are in disrepair and are therefore in mercy two shillings fine

They also present that the aforesaid inhabitants, who do not have (English) a Rook net according to *single form of tenure* and offend against the statute and are therefore in mercy twelve pence fine

They also present that Thomas Badcock, a customary tenant of this manor, who held from the lord of this manor a messuage or tenement and two virgates and a half of arable land with appurtenances, has died since the last court, and therefore two herriots fall to the lord, that is two best beasts. Also that Anne, his wife, shall have and enjoy the said premises during her widowhood and that the lord, by his steward, transfers possession to her by the rod and she is thereby admitted as tenant and did fealty to the lord according to custom.

Similarly they present that **Simon Richards**, a customary tenant of this manor, who held from the lord of this manor a messuage or tenement and one and a half virgates of arable land with appurtenances, has died since the last court and a gelding owing to the lord *is to be given*. Also that **Amie, his wife**, shall have and enjoy the said premises during her widowhood and the lord, by his steward, thereby transfers possession to her by the rod and she is thereby admitted tenant and did fealty to the lord according to custom.

They also present that Osmundus Adkins caused a nuisance (English) in the common stream, by throwing waste into the same, to the great inconvenience of tenants there, and is fined twelve pence.

Orders It is ordered that tenants of this manor shall attach rings to their pigs under pain, for each pig for each time, whoever is in default, of a fine of three pence and three shillings

Pains It is ordered that tenants of this manor dig out and clear the ditch called Grandpre from Myngstone Sade up to Vernant le Wirge by the feast of the next holy day, under pain for each defaulter of two shillings.

Pains It is ordered that the Homage is to meet for setting more stones between tenant and tenant and that this must be completed before the next Feast of Pentecost, called Whit Sunday, under pain for each defaulter of two shillings.

William Badcock is elected tithingman and is sworn.

Robert Mayo and Thomas Woodliffe are elected in the office of leymen and are sworn.

### Notes

The will of Simon Richards is still extant and is held in the Berkshire Record Office. It has a date of 2<sup>nd</sup> November 1591, although it appears that Simon died prior to this court, held in April. His wife, Amy, and son Thomas are appointed executors of the will.

The Thomas Richards in the jury and Homage is probably this son.

The butts referred to above were the shooting butts for villagers' archery practice. Henry VIII had revived their use and upkeep by statute.

A statute of 1532 (Henry VIII), For the Destruction of Crows and Rooks, required each village to maintain and use a rook net to prevent harm to crops, upon pain of a fine to the crown. This record is from April when rooks were beginning to nest and crops had been sown. Perhaps each tenant was responsible for their own net in this village.

The stones referred to may be boundary stones between the property of various tenants or those to mark the parish boundary.

The tithingman was responsible for seeing that tenants kept the peace.

The office of leyman was probably the abbreviated form of barleymen, itself a contraction of byrelawman (by our law man). These officials were constables, responsible for assuring the observance of bye-laws.
