Manor of Wootton and Boarshill
In the county of Berkshire

Court Baron of Richard Hyde ,gentleman, and Elizabeth, his wife. Held here by his steward, Thomas Rede, on the first of November in the thirty-fourth year of the reign our Lady Elizabeth, Queen of England, France and Ireland, Defender of the Faith.

The Homage present on their oath they present that Nicholas Badcock William Truelock and William Badcock did not maintain the common public area (in English The Pound) according to the agreed penalty and each is therefore fined two shillings and two pence. The day by which repairs are to be made is twenty days hence before the Feast of Saint Nicholas under pain of fine for each of ten shillings

Present They also present that Osmund Adkins and Richard Badcock kept more cattle than agreed and each is therefore in mercy two shillings.

Present They also present that Thomas Woodliffe, Richard Broughton , **Amie Richards widow** and William Badcock allowed their pigs to go without rings (in English unringed) and each is thereby in mercy two shillings.

It is also ordered that each of the custom shall keep their horses (in English led or bridled) upon the high ground until twenty days after the Feast of Ascension under pain for each of four shillings fine.

Death of Maude Mayo widow Those sworn in this court present that Maude Mayo, widow, who held from the lord of this manor two tenements or two messuages and one yardland of land with appurtenances called *Poulds* and Dolpitte, has died since the last court. One sheep is due as heriot to the lord and Thomas Mayo, executor and son, is admitted by fixed title to the said premises, to whom the lord by his steward thereby gives possession and he is thereby admitted as tenant and did fealty to the lord.

Surrender by Robert Mayo and concession to Richard Mayo

Robert Mayo came to this court and surrendered into the hands of the lord of this manor all his fixed title, interests and leases which the said Robert held by annual rent . That is to say a toft and one yardland of arable land called Verrells and a messuage and one quarter of a yardland with appurtenances called *Posifits* , formerly in the tenure or occupation of the said Robert by annual rent of *twenty shillings* . They present that the lord released possession to Richard, the son of the said Robert Mayo. The said Richard Mayo came to this court and took possession from the lord, by his steward Thomas Rede, of the said toft and one yardland of arable land, called Verrells, and also a messuage and a quarter of one yardland of arable land, called *Posifits* . The lord, by his said steward, thereby gave possession by the rod to the said Richard of the said toft and one yardland and one messuage and one quarter of a yardland with appurtenances, for the said Richard to have and to hold for the term of his life, at the will of the lord, according to the custom of this manor, rendering to the lord by annual rent *twenty shillings* , a heriot having been paid, and rendering all services and customs formerly owed or by right owing. A heriot falls due , according to the custom of this manor. He gives to the lord an entry fine of *thirteen shillings* , pledged fealty to the lord and was thereby admitted as tenant.

In this court Richard Howell was elected to the office of *tithingman* for the next year and was sworn.

Notes

The pound was the area in the village where stray animals were kept and secured until reclaimed by their owners.

Fines were imposed on villagers if they allowed more than an agreed number of animals to graze on common land. This numerical “stint” , as it was known, was to prevent over-grazing.

Pigs were required to be ringed to prevent them rooting up common or arable land.
