## Court Roll 1597

Manor of Wootton and Boarshill  
In the county of Berkshire

Court Baron of Richard Hyde, gentleman, and his wife Elizabeth, held there by his steward Thomas Rede on the *sixth* day of October in the thirty ninth year of the reign of our lady Elizabeth, Queen of England, France and Ireland, defender of the faith.

The homage present on their oath they present that the pound is in disrepair and that Richard Badcock and Thomas Mayo are therefore in mercy and that the due date for these persons to repair the said pound is twenty days hence before the feast of All Saints, under pain of default for each of 3 shillings and 3 pence. The lord of the said manor allocates an allowance of 3 shillings and 3 pence.

Presentment they also present that Richard Badcock kept more horses than is allowed and is therefore in mercy 3 shillings and 3 pence.

Penalties It is ordered that henceforth no-one shall put sheep in the stubble field (in English break the stubble field) according to the assent and agreement of the tenants of this manor, under pain of default for each of 3 shillings and 3 pence.

Penalties it is also ordered that the said homage shall meet in the West Field at Lassford Gate on the twentieth day after the feast of All Saints between the hours of nine and eleven in the morning of that day to set the boundaries (in English merestones) between tenants, under pain of default of twelve pence. Similarly to meet in the Hetching Field at Whitecross by the *crossroads* to set the boundaries (in English merestones) between tenants under pain of default of twelve shillings.

Also it is ordered that henceforth, until the next court, no constables but a different tenant shall be elected also to the office of tithingman.

Concession to John Bond     John Bond came to this court and received from the lord of this manor a toft and one yardland of land with appurtenances called Fanbury, and a messuage with half a yardland of land with appurtenances called *Punfre or Ponfre* rendering rent of one shilling, and a messuage and one yardland of land called *Palends* rendering an annual rent of eight shillings, formerly in the tenure or occupation of the father, Edward Bond, of the said John Bond; now in the tenure or occupation of the said John Bond and rendering the customary tenure of this manor. In court, the lord, by his said steward, thereby transferred possession to him, to have and to hold the said toft with all and singular said premises with appurtenances for the said John Bond for the term of his life at the will of the lord, according to the custom of the said manor and rendering thus annually twenty three shillings and all services and customs formerly owed and by right accustomed. Heriots fall due to the lord, according to the custom of the manor. He gave a fine to the lord for fixed title and entry, was thus *inheritor*, did fealty to the lord and was thereby admitted as tenant for *twenty pounds*.

#### Election of officials

Thomas Woodliffe is elected by this court to the office of tithingman and is sworn.

Richard Mayo and **Thomas Richards** are elected by this court to the office of leymen (constables) and are sworn

#### Notes

The crossroads at Whitecross still bear the name today and there is a nameplate at the roadside.

The village pound for stray animals was obviously the responsibility of the named tenants, who had let it fall into disrepair. A modern street on the site is named The Old Pound.

Richard Badcock must have allowed too many of his horses to graze the common land.

Animals must have been allowed to graze the field of stubble after harvesting until this time.

Perhaps one of the elected constables had also wished to stand as tithingman, but the court decided that each man could only serve in one office.
