The Homage

presents on their oath they present that Richard Badcock did not attend the meeting at Lassford according to the order, therefore he is fined twelve pence

They also present that Thomas Woodliffe did not clear the ditch called Madlyone, therefore he is in mercy and that the last day given by which the ditch is to be restored and repaired is twenty days after the 25th of April, under pain of two shillings fine.

They also present that Thomas Mayo did not repair his part of the said ditch, therefore he is in mercy and fined three shillings and three pence and the last day given for the repair and restoration of the said part is twenty days hence before the Feast of Pentecost, under pain of two shillings fine.

Pains it is ordered that the residents of Boarshill make the gateway good and sufficient (in English The Boarshill gate) twenty days hence in May under pain of ten shillings fine.

Pains it is also ordered that the Homage meets together at Whitecross twenty days after Ascension Day for setting the boundary (in English new stones in the lower Vil field) and this is required under pain of each defaulter to be fined three pence.

Pains it is also ordered that none of the custom (in English the vil) shall allow any mares with a colt (in English a suckling colt) in the common field while the crop is growing , under pain for each defaulter for each time of a fine of six shillings and eight pence

Concession

To Richard Badcock At this court the Lord, by his steward , in open court transferred to Richard Badcock, Renicoem, a messuage and one virgate of land (English in Boarshill) according to the custom of the manor lately in the tenancy of the said Richard Badcock and to the said Richard by yearly rent of twelve shillings. The said premises of Renicoem, a house and one virgate of land in the said Boarshill by the custom of the manor in the tenancy of the said Richard Badcock by yearly rent is for the said Richard Badcock to have and to hold the said Renicoem all and singular said premises with all and singular appurtenancies for his whole life at the will of the Lord according to the custom of the said manor, and that , after death , when transferred from the said Richard Badcock to his heirs, it is subject to fines owing seventeen shillings by return of service and custom and other services formerly owed and by right accustomed and by customary law two herriots fall owing by the custom of the manor. And the said Richard Badcock paid twenty pounds to the lord for fixed title and access and has entry to the said premises and paid fealty and respect to the lord according to custom.

Concession

To John Cockins To this court came John Cockins and received from the lord of this manor a tenement newly built and a piece of land adjacent to this building of an estimated area of half an acre situated in Boarshill within this manor together with a pasture of one virgate within this manor.; which possession the lord, by his steward, transferred to him by the rod, for the said John Cockins to have and to hold the said tenement and all other and singular of the said premises for his whole life at the will of the lord according to the custom of the manor by return of monthly rent of six shillings and six pence for the rendering of all other services by custom and other services formerly owed and by right accustomed. And he gives to the lord a fine of twenty shillings for fixed title and access and is thereby admitted as tenant and he did fealty to the lord according to custom.
