Baron Death of Elizabeth King & Rev. Henry Gabell. Land to the lord.

22nd June 1832

Homage as above. Stroud Tubb continued (sic) tythingman

Baron Death of Mrs. Walker (late Bertie) by whose sole life was holden an estate called Sweatman's Farm & Cottage at Chawley & which estate is now fallen to the lord

Richard Stone surrendered estate.

Leet James Richards, his death

The Jury & Homage present the death of James Richards since the last court and that there are two lives remaining in the lease of the premises holden to him, namely Thomas Richards and Benjamin Richards

1840 Death of Thos. Faulkner. Estate to Mary Faulkner wife & absigns. Also a lease with two lives, John Faulkner & Jane Godfrey, late Jane Faulkner, spinster.

1841 Mary Faulkner admitted

1846 Death of Richard Stone. Susanne Stone admitted
